



2018 RETAILER INCENTIVE PROMOTION TERMS AND CONDITIONS

Entrants will be deemed to have accepted these terms and conditions, and agreed to be bound by them, when entering this free prize draw (the “Promotion”).

Who may enter:

1. You are eligible to enter into this Promotion if you:
 - a) Are the owner or an authorised employee of any independent retailer or symbol group situated in the UK and have your employer’s permission; and
 - b) are aged 18 or over.
2. Employees (or family members of employees) of any group company of the Promoter, companies associated with the Promotion, and all affiliates of such companies may not enter this Promotion.

How to enter:

Winners selection and notification:
